## **Donhead Preparatory School**

### **Admissions Policy**

(EARLY YEARS, PRE-PREP AND PREP DEPARTMENTS FOLLOW THIS POLICY AND GUIDANCE)

Donhead Preparatory School is a Roman Catholic independent school for boys and girls, aged 3-11 years, in the trusteeship of the Society of Jesus.<sup>1</sup>

Jesuit schools strive to give a first-class education, but they are also places committed to outstanding character formation. We believe in 'cura personalis' – development of the whole person. Each child will experience this differently, based around their interests, talents, choices and personality, but all will benefit from this approach. While academic performance is important, learning and personal growth extends far beyond the classroom at Donhead.

Families are warmly invited to visit Donhead on an Open Morning or for a personal tour of the school to see our values in action.

#### **Admissions Criteria**

The priority in the allocation of places, in all Year groups, is given as follows:

- Category 1: Pupils with a sibling at Donhead (past or present)
- Category 2: Baptised and Practising<sup>2</sup> Catholic pupils
- Category 3: Baptised Catholic pupils
- Category 4: Other applicants who are supportive of the Catholic ethos of the School.

If more applications are received than places are available, the date of registration will be reviewed, and earlier applications prioritised.

#### **Pre-school Admissions**

Children join the pre-school each September following the child's third birthday (3+). Children will spend a maximum of three terms in the pre-school before moving into Reception. Children joining the pre-school transition to our Reception class in the September after their 4th birthday and we guarantee them a place.

All children registered for the pre-school will be invited to attend a taster session or have a nursery / home visit prior to starting at Donhead.

Our pre-school provision is based on a progressive curriculum where learning is built upon each day. Our attendance offering is therefore as follows:

- Monday - Friday (5 days per week, whole day attendance)
- Monday - Friday (5 mornings per week, half day attendance)
- Monday - Friday (5 mornings per week, half day attendance plus selected afternoons with a term's notice)

From the term before Reception, attendance is compulsory on Monday to Friday (5 mornings per week, half day attendance plus a minimum of 2 afternoons) to ensure the pupils are 'Reception Ready'.

Our pre-school does not have nappy changing facilities. Whilst we do understand that young children may have occasional accidents, we do expect that children joining us are out of nappies, dry during the day and able to use toilet facilities independently.

### **Reception Admissions**

All children with an accepted place for Reception will be invited to attend a taster session or have a nursery / home visit prior to starting at Donhead. Children currently in the Donhead pre-school have a guaranteed place in Reception.

Children are admitted into the Reception Class in the September after their 4<sup>th</sup> birthday as full-time pupils.

Parents<sup>3</sup> of summer born children (1<sup>st</sup> April to 31<sup>st</sup> August) may request that their child's entry into the Reception Year is deferred to the following September. The school is under no obligation to agree to this request but will make its decision based on the circumstances and in the best interests of the child involved. This will involve consideration of (amongst other things):

1. the parents' views;
2. information about the child's academic, social and emotional development;
3. the child's medical history (where relevant);
4. whether the child has previously been educated out of the normal age group.

### **7+ Admissions**

The assessment for entry into the school at 7+ (Year 3) will take place in November. To sit our 7+ assessment children need to be registered with Donhead using the link below.

### **Occasional Places**

Occasional vacancies may be available in other year groups and parents are advised to contact the school directly. Children registered for an occasional vacancy are required to complete an application process that will include:

1. Completion of a taster day.
2. Satisfactory completion of standardised assessments in Maths and English (Years 1-6)
3. A satisfactory school report and confidential reference/or direct contact with current school.

### **Joining the School**

We aim for a smooth and gentle introduction to school so that all children are happy, secure and ready to learn. Parents are invited to a New Parents' Welcome Evening in Trinity Term and all parents are invited to a Curriculum Information Session at the start of the Michaelmas Term.

### **Equal Treatment**

The school is committed to equal treatment for all, regardless of their race, ethnicity, religion, sexual orientation or social background and follows the guidance contained in the Equality Act 2010. We welcome applications from pupils with as diverse a range of backgrounds as possible. This enriches our community and is vital in preparing our pupils for today's world.

### **Religious Beliefs**

We welcome pupils from other faiths who support our Catholic ethos. Parents/guardians must agree to pupils attending Mass, Collective Worship and participating actively in RE lessons.

### **Individual Learning Needs**

We welcome pupils with individual learning needs, providing that our Learning Support Department can offer them the support that they require. We welcome pupils with physical disabilities provided

that our site is accessible to them; please see our Accessibility Policy. However, we advise parents of children with special educational needs or physical disabilities to discuss their child's requirements with us before or during their tour of the school so that we can discuss adequate provision for them. Parents should provide a copy of an Educational Psychologist's, other professional or a medical report to support their request, if available. Any reports from previous schools should be submitted on application. We will discuss thoroughly with parents, and their medical advisers, the adjustments that can reasonably be made for the child if they become a pupil at the school.

For students who are undergoing Education Health and Care (EHC) needs assessment or who already have EHC Plan (EHCP) in place, the admissions process is different and in line with the procedures of the Local Authority (LA) that is responsible for the plan. We will liaise with the child's educational setting, the professionals involved in their support and the LA's representative, the child's Case Officer, to establish whether Donhead is a suitable placement for the child's individual needs and compatible with the efficient education of others or efficient use of resources.

A separate meeting with school SENDCo, Ms Plech-Blair will be arranged to offer you an opportunity to discuss your child's individual needs and support requirements.

### **Registration**

Parents are invited to register their interest by completing a registration form, available for completion via the school website <https://www.donhead.org.uk/admissions/online-registration-form> and paying the non-refundable Registration Fee of £100.

### **Important Dates**

When a place is offered, parents are asked to accept the offer and return the Acceptance Agreement with a deposit of £1,000. £500 of this is a **non-refundable Enrolment Fee** and the other £500 is taken off the parents' final invoice when they leave Donhead. If the offer of a place is subsequently withdrawn, following the receipt of an unsatisfactory Nursery/School report, then the Enrolment Fee will be refunded in full.

Offers are subject to:

1. Parents having visited the school / met (in person or virtually) with Admissions Team or Headteacher.
2. A satisfactory Nursery/School report (if applicable).
3. A successful taster session/ home visit /visit to the Nursery.

For parents residing overseas during the Applicant and Admissions process a tailored process will be agreed. Payment of the first term's fees shall become payable on the last working day (5pm) of the **term prior to entry.**

Withdrawal after this date means that the term's fees paid will be forfeited.

3. *Parents or the adult with parental responsibility for the child.*
